The Federation of Beaufort & Langley Schools is governed by an Interim Executive Board (IEB), which was appointed in November 2022. The board was put in place following intervention by the local authority. We are nominated by them, and the appointment of each member is approved by the Department for Education.

We are here to effect rapid improvement and change in our schools, and we are focused on the provision for and development of our children. We can be more involved at an operational level than a typical school governing board, particularly with support, and as such, the board has five very experienced education professionals, including three current/former head teachers, a national leader of education, an experienced buildings surveyor and an experienced local community governor.

We will draw on other expertise, such as school improvement and SEND finance when needed. All members visit both schools on a regular basis, to ensure that we are moving forward, and doing so together. We look forward to meeting parents across our schools at various events and forums during the course of our tenure.

ANDREW COLLYER, Chair

I am the founder of a specialist business change and transformation consultancy, working in several countries with over 500 organisations at board level involving leaders, management and shareholders.

I have been a governor, trustee and member of five governing boards, including two IEBs, and am highly adept at developing the boards. I have completed the Chairs' Development Programme and I am a designated National Leader of Governance by the Department for Education. I have been involved in school governance and school improvement recently in number of settings with a particular focus on keeping children safe.



BARRY HUNT

I have worked for many years in the construction industry up to Director level before joining local government in the 1990s and retiring in 2017, as a senior manager with Acivico Facilities Management, who manages the Council's entire property portfolio.

In 2016 I became co-opted governor and committee chair of a local primary school which at the time was in special measures (and is now rated good) and had a large budget deficit (which was cleared in 2022). I have also been for 3 years a public governor of the University Hospitals of Derby and Burton Foundation Trust which operates across 5 hospital sites and employs over 13,000 staff.



STEVE HUGHES

Until 2022 I was CEO of the Education Impact Academy Trust, who educates over 20% of Birmingham's special school pupils and employs over 600 staff. I was previously Head Teacher of Wilson Stuart School, judged Outstanding by Ofsted six times. Born and bred in Birmingham, I am proud of my City. I was privileged to spend my working life as a teacher and impact positively on the lives of children and their families, including as school improvement Senior Leader for over 30 years. I served on the 2012 London Olympics Head Teacher Committee and the Birmingham Schools Forum, and chaired the Birmingham Special Forum and the Birmingham Special School Head Teachers Association.



LAUREN HALLIDAY

I am a qualified solicitor who worked at my current firm since 2011, specialising in defending clinical negligence claims. I was appointed on Beaufort and Langley's Federated Governing Board in 2021 and am now the safeguarding governor for Langley on the IEB.
